

**ENFIELD BOARD OF EDUCATION
POLICY COMMITTEE MEETING
MARCH 17, 2026 MINUTES**

The March 17, 2026 Policy Committee Meeting was called to order by Ms. Brocuglio at 5:00 PM.

Roll Call: Rosalee Brocuglio, Janet Cushman, Kelsey McGuire-Bruce

Absent: None

Also Present: Board Chair Amanda Pickett, Superintendent Steven Moccio, Deputy Superintendent Andy Longey, & Director of Operations John Dague

Discussion:

John Dague requested reordering the agenda to have items from the table first due to meeting time constraints. No objections.

Items from the Table:

1. Steven Moccio shared a revised *Policy 5111 – Admission to Public Schools at or Before the Age of Five*. Ms. McGuire-Bruce made a motion to move the revised policy to a first read at the next Board meeting. Ms. Brocuglio seconded the motion. A vote of Policy Committee Members by a show-of-hands 3-0-0 passed unanimously.
2. John Dague shared *Policy 5112 – Age of Attendance/Dropouts* for repeal. After review, the policy repeal was tabled pending investigation of existing policy(s) concerning birth to three services and enrollment criteria.
3. Ms. Cushman discussed reviewing 7000 series policies concerning new construction, in light of the pending school construction referendum. The committee discussed that there was no 7000 series model policies available from Shipman and Goodwin. The committee will review sample policies from surrounding districts at a future meeting if provided.

Policy Discussion:

- Policy 6111 – School Calendar(s)
 - The committee reviewed changes to the policy to allow setting a firm graduation date on or after the 180th day of school during the calendar adoption process. Ms. McGuire-Bruce made a motion to move the revised policy to a first read at the next Board meeting. Ms. Brocuglio seconded the motion. A vote of Policy Committee Members by a show-of-hands 3-0-0 passed unanimously.
- Policy 6111.1 – School Calendar

- The committee discussed repealing the policy as redundant after accepting changes in policy 6111. Ms. McGuire-Bruce made a motion to move the revised policy to a first read at the next Board meeting. Ms. Brocuglio seconded the motion. A vote of Policy Committee Members by a show-of-hands 3-0-0 passed unanimously.
- Proposed Policy 9240 – Board of Education Member Attire
 - Ms. Cushman proposed the policy. After discussion, Ms. Cushman made a motion to move the policy to a first read at the next Board meeting. No member seconded the motion and the motion failed.
- Replacement of current 1000 series policies with Shipman & Goodwin model policies
 - The committee discussed reviewing Shipman and Goodwin policies and the identified aligned policies for the next meeting. *Policy 1330 – Use of School and Town Facilities* will be reviewed following the completion of the revision work currently taking place with the Town of Enfield.

Adjournment:

Ms. McGuire Bruce moved, seconded by Ms. Brocuglio to adjourn the March 17th, 2026 Policy Committee meeting. A vote of Policy Committee Members by a show-of-hands 3-0-0 passed unanimously.
