Call to Order & Pledge of Allegiance

Chairman Fiore called the meeting to order at 6:31 PM.

Roll Call

Commissioner DeGray took the roll and present were Commissioners Lewis Fiore, Virginia Higley, Kenneth Hilinski, Linda DeGray, and Alternate Commissioner Nicles Lefakis, and Christian D'Antonio. Absent was Commissioner John Petronella, Francis Alaimo, and Alternate Commissioner Vinnie Grillo.

Chairman Fiore seated Alternate Commissioners D'Antonio and Lefakis as regular members.

Approval of Minutes

- a. May 25, 2023 – Regular Meeting

New Business

- a. **APA# 26- 7 Moody Road-** Application for an Aquifer Registration Renewal over the A45 and A50 Aquifers; Denis Lessard, Applicant; Seven Moody LLC, Applicant/Owner; Map 75/Lot 37; I-1 Zone

Commissioner DeGray read the legal notice into the record. Applicant representative and property owners were present for discussion. They are seeking a renewal for regular activities. These properties were initially registered in 2008 and not much has changed since then. The site

still complies with the regulations. Ms. Driver gave feedback. Site inspection was done, and the site was well organized and clean. Her only recommendation was to relocate the dumpsters to an impervious surface, which has been satisfied. DPH and DEEP were notified and no significant comments were received. Chairman Fiore directed commissioners to disregard the dumpster recommendation in Ms. Driver's report.

Motion to approve APA # 26 – 7 Moody Road made by Commissioner Higley; seconded by Commissioner Hilinski and approved by a roll call vote of 6-0-0.
